Família pakistanesa ataca jovem de 22 anos com machado por pedir divórcio

A família de Sobia Batool Shah, de 22 anos, invadiu a betano tem cashback casa enquanto ela e a betano tem cashback família dormiam. Eles procuraram Sobia e um deles atacou-a com um machado, golpeando-a nas pernas betano tem cashback um esforço para amputar-las. "Ele era implacável e deve ter me atingido pelo menos 15 vezes", diz ela.

"Eu gritei de dor e implorei-o para parar, mas ele estava possuído", adiciona. "Eu mesmo lhe disse que não procuraria o divórcio."

Sobia foi atacada por homens da betano tem cashback própria família - incluindo o seu pai, Syed Mustafa Shah, o seu tio e primos - que invadiram a casa como "punição" por recusar retirar a betano tem cashback candidatura de divórcio do marido.

Falando ao Guardian por telefone do Hospital Universitário do Povo das Ciências Médicas e da Saúde, na cidade de Nawabshah, onde ela está a ser tratada, Sobia diz que está betano tem cashback "dor intensa" e as suas pernas estão betano tem cashback gesso.

"Os médicos colocaram uma vara betano tem cashback uma perna", diz ela.

Sobia Batool Shah está a recuperar no hospital depois de ter sido atingida nas pernas por uma multidão de parentes masculinos, incluindo o seu pai.

"Trata-se de poder e controlo", diz a Dra. Summaiya Syed Tariq, cirurgiã-chefe da polícia betano tem cashback Karachi, capital da Sínde.

A Dra. Syed Tariq, que também dirige o departamento de medicina legal da polícia de Karachi, viu centenas de mulheres física e mentalmente abusadas, estupradas, queimadas e assassinadas ao longo dos últimos 26 anos.

"Estamos criando abusadores que são piores que animais", diz ela.

Num dia normal, o departamento recebe relatos de cerca de seis casos de violência sexual e 10 a 15 casos de violência doméstica betano tem cashback centros de medicina legal betano tem cashback três hospitais públicos betano tem cashback Karachi.

"Na minha avaliação, para cada três casos que nos chegam, sete mais ficam sem ser relatados. E não estou a contar com os corpos sem vida que recebemos", adiciona a Dra. Syed Tariq.

A desigualdade de género é um problema global, mas os indicadores do Paquistão reflectem taxas especialmente alarmantes de disparidades e violência enfrentadas por mulheres. Segundo o relatório de 2024 do Índice de Desigualdade de Género das Nações Unidas, o Paquistão está classificado betano tem cashback 164º lugar entre 193 países.

Abdullah Lakhair, subinspector-chefe de polícia betano tem cashback Naushahro Feroze, diz que o pai da vítima admitiu o ataque, dizendo à polícia que a betano tem cashback filha tinha trazido "desonra" à família ao pedir o divórcio.

Se não tivesse sido pelo meu tio, não teríamos um telhado sobre a nossa cabeça. Como o meu pai pode falar do seu honor sendo manchado pelo meu divórcio?

Ela havia pedido às autoridades proteção depois de o seu pai ter ameaçado matá-la anteriormente. "No mês passado, o juiz do distrito a tinha remetido para um abrigo de mulheres, onde ela ficou por duas semanas, mas depois decidiu regressar à betano tem cashback mãe. O incidente aconteceu pouco depois", diz Lakhair.

Sobia diz que o seu pai abandonou a betano tem cashback mãe e irmãos e cortou todos os laços com eles. "Se não tivesse sido pelo meu avô materno e pelo meu tio, não teríamos um telhado sobre a nossa cabeça todos estes anos. Como ele pode falar do seu honor sendo manchado pelo meu divórcio", diz ela.

Lakhair diz que o pai de Sobia está à espera de sentença e poderá enfrentar até 14 anos de prisão.

O incidente provocou reacções indignadas da população e organizações da sociedade civil no Paquistão. Anis Haroon, ativista dos direitos das mulheres e ex-presidente da Comissão Nacional sobre o Estatuto das Mulheres, viajou de Karachi para visitar Sobia no hospital. Ela é cética quanto ao caso provocar quaisquer mudanças significativas.

"Assim como tantos incidentes aterradores no passado, este será logo esquecido", diz ela. O Paquistão tem as leis, mas não a "vontade política" de as implementar, adiciona.

"Os legisladores pensam que o seu trabalho termina depois de as leis serem aprovadas betano tem cashback assembleias. Eles falham betano tem cashback se esforçar para as implementar", diz Haroon.

Depois do ataque a Sobia, a betano tem cashback mãe foi ter com os vizinhos para pedir ajuda, pensando que a betano tem cashback filha inconsciente havia perdido tanto sangue que devia ter morrido.

"Depois de lhe ter dado assistência médica imediata, enviamos-la para Nawabshah, uma hora e meia de distância daqui", diz Lakhair. "Ela teve de ser dada 10 bolsas de sangue, que a polícia arranjou. Ela está betano tem cashback segurança, por agora."

Embora o seu pai esteja na prisão à espera de sentença, Sobia tem proteção policial 24 horas por dia no hospital.

"O meu pai foi apreendido, mas o seu irmão foi posto betano tem cashback liberdade sob fiança. Estou muito assustada", diz ela.
