Palmeiras enters with lawsuit against John Textor at STJD for statements about match manipulation

The Palmeiras has filed a lawsuit against John Textor, owner of the Botafogo, at the Superior Court of Justice in Sports (STJD) due to statements made by Textor about match manipulation. The lawsuit seeks financial punishment and suspension of Textor for each statement involving Palmeiras in match manipulation.

In an interview, Textor had stated that he had evidence of match manipulation involving the Palmeiras and presented a report from a company called GoodGame, which he had hired to analyze the Brasileirão matches. The report indicated that the Palmeiras had been benefited in several matches, including the game against the Botafogo, where the Palmeiras won 4-3. Following the interview, the STJD decided to open an investigation to investigate the claims made by Textor. The Botafogo director was summoned to present evidence, but the STJD decided against suspending Textor, arguing that it was not necessary to suspend him as the investigation was still ongoing.
