Metropolitan Victorian Thoroughbred:

In any one Win, Win/Place or Each-way bet: to loseR\$2000

When do the Minimum Bet Limit conditions commence? The conditions commence on 1 October 2024.

Who must comply with the conditions?

A list of approved wagering operators is available here. Note that the minimum bet limit conditions do not apply to interstate on-course bookmakers that operate on Victorian thoroughbred racing. The conditions applicable to Victorian licensed on-course bookmakers are available here. All approved off-course Australian wagering operators who are approved to use Victorian thoroughbred race field information (excluding Victorian on-course bookmakers). A list of approved wagering operators is available. Note that the minimum bet limit conditions do not apply to interstate on-course bookmakers that operate on Victorian thoroughbred racing. The conditions applicable to Victorian licensed on-course bookmakers are available

Do the conditions apply to races held in Victoria only?

Racing NSW has similar conditions which apply to fixed odds bets on NSW thoroughbred races. Yes. The conditions apply to fixed odds bets on Victorian thoroughbred races. This will include telephone and internet bets placed on Victorian thoroughbred races, but exclude bets placed in a retail outlet. Racing NSW has similar conditions which apply to fixed odds bets on NSW thoroughbred races.

What are the betting limits imposed under the conditions? Approved Australian off-course wagering operators are required to lay the odds displayed for fixed odds bets to the limits below:
Race Type Bet (Win, Win/Place or Each Way) Bet (Place Only) Metropolitan Victorian Thoroughbred races R\$2,000
Non-metropolitan Victorian Thoroughbred races R\$1,000
R\$400 The MBL conditions are included under the RV Race Fields Policy and are available on the Racing Victoria website. Approved Australian off-course wagering operators are required to lay the odds displayed for fixed odds bets to the limits below:

Why does the Minimum Bet Limit not apply to Victorian on-course bookmakers?

Note that the minimum bet limit conditions do not apply to interstate on-course bookmakers that operate on Victorian thoroughbred racing. Victorian licensed on-course bookmakers already have minimum bet limit requirements, outlined in the Rules of Race Betting on the Racing Victoria website. From time to time these requirements may be amended. Note that the minimum bet limit conditions do not apply to interstate on-course bookmakers that operate on Victorian thoroughbred racing.

Why doesn't the minimum bet limit apply if my bet is with an unlicensed wagering operator?

Customers who choose to bet with an unlicensed wagering operator expose themselves to many risks as these operators are not bound by Consumer Protection laws. The minimum bet limit policy only applies to transactions with licensed wagering operators approved to use Victorian thoroughbred race field information outlined in question 2.

Do the conditions apply to multi bets? No. The calculation of multi-bets, where some of the legs are not related to fixed odds bets on Victorian thoroughbred product could be complex. For this reason, multi-bets have been excluded.

How many bets is a wagering operator obliged to accept to the limit from a punter? Wagering operators are only required to bet to the limit once per horse for each customer for each race.

This could be one fixed odds bet to the limit or a number of fixed odds bets which together add up to the limit. No. The calculation of multi-bets, where some of the legs are not related to fixed odds bets on Victorian thoroughbred product could be complex. For this reason, multi-bets have been excluded.

Can I attempt to bet more than the limit? Yes. An operator is obliged to accept a bet up to the minimum bet limit amount (subject to the exclusions), however, they may be prepared to accept more than the minimum bet limit.

What price does a wagering operator have to bet each punter? All punters are entitled to the price publicly displayed in the wagering operator's latest betting market on their website or app. The only time a changed price can be offered after a punter places a bet is if the official Victorian Official Price (VOP) had just changed or another bet has been layed at the original price and the wagering operator is adjusting the price, which will flow through to their website or app. Time log records can be checked to confirm this process.

What type of bets do the conditions apply to? The conditions only apply to fixed odds Win, Win & Place, Each Way or Place bets on Victorian thoroughbred races. They do not apply in respect of bets placed as part of a betting exchange. They also do not apply to free bets or bonus bets, derivative bets such as best tote or exotic bets such as quinellas and trifectas. Bets which do not have a determined return at the time of placing a bet (e.g. Top Fluc or SP) are also excluded.

Can a wagering operator close an account, refuse to open an account or place limitations on an account to avoid accepting a fixed odds bet to the limit?

However, wagering operators are still able to take such actions for legitimate reasons including bowlers (persons betting on behalf of other persons), responsible gambling practices, fraudulent activity, money-laundering and other integrity-related reasons such as the punter being warned off or disqualified or where Racing Victoria is satisfied that the reason the Approval Holder has not complied properly falls within the Racing Victoria list entitled "Further reasons where an Approval Holder is not required to comply with clauses 12.1.1 and 12.2.1" as published on its website and amended from time to time. No. Wagering operators are not to take actions such as closing a punter's account, refusing to open a punter's account or placing restrictions on a punter's account solely to avoid complying with the minimum bet limit conditions. However, wagering operators are still able to take such actions for legitimate reasons including bowlers (persons betting on behalf of other persons), responsible gambling practices, fraudulent activity, money-laundering and other integrity-related reasons such as the punter being warned off or disqualified or where Racing Victoria is satisfied that the reason the Approval Holder has not complied properly falls within the Racing Victoria list entitled "Further reasons where an Approval Holder is not required to comply with clauses 12.1.1 and 12.2.1" as published on its website and amended from time to time.

Do the conditions apply to pre-post betting? No. The minimum bet limit conditions apply to fixed odds bets placed after Final Acceptances Deadline.

Do the conditions apply to bets in a retail outlet? No. At this stage, the minimum bet limits will not apply to bets placed in retail outlets (regardless of whether cash or account betting), including interstate and Victorian TAB agencies, hotels, clubs and pubs, primarily due to the difficulties associated with determining whether a bet in a retail outlet is a bowler bet placed on behalf of another person.

Is the wagering operator obliged to extend credit to a punter to make a bet to the limit? No. If the punter does not have sufficient funds to pay for the bet, the wagering operator is not obliged to accept the bet.

What should a punter do if they have a complaint?

If the punter remains unsatisfied with the reason provided by the wagering operator, and they do not fall within one of the exclusions listed in the conditions, then they may lodge a formal complaint with Racing Victoria by completing and submitting the complaints form found on the Racing Victoria website here.

Complaints will only be accepted and investigated following submission of a fully completed complaints form. Rude, abusive or offensive submissions will be disregarded.

A summary of the formal complaints process can be found here. At first instance, punters who

believe that a wagering operator has refused their bet or excluded them in contravention of the minimum bet limit condition should contact the wagering operator to ascertain the reason for the refusal or exclusion. If the punter remains unsatisfied with the reason provided by the wagering operator, and they do not fall within one of the exclusions listed in the conditions, then they may lodge a formal complaint with Racing Victoria by completing and submitting the complaints form found on the Racing Victoria website. Complaints will only be accepted and investigated following submission of a fully completed complaints form. Rude, abusive or offensive submissions will be disregarded. O que são horários pagantes no Onabet?

Horários pagantes no Onabet são horários específicos em que a 2 plataforma oferece cotas melhores do que as normais em determinados eventos esportivos. Esses horários variam de acordo com o esporte 2 e o evento em questão, e podem ocorrer em diferentes momentos do dia ou da noite.

Por exemplo, em um jogo 2 de futebol, o Onabet pode oferecer cotas melhores durante o primeiro tempo do jogo, ou mesmo durante os últimos minutos 2 do segundo tempo. Em outros esportes, como o tênis ou o basquete, os horários pagantes podem ocorrer durante os sets 2 decisivos ou nos momentos finais dos jogos.

Furtivas tempestades destruyen vehículos, provocan evacuaciones e inundaciones récord en Texas

Ferozes tormentas elétricas descargaram chuvas destruidoras que varreram veículos e desencadearam evacuações, forneceram granizo do tamanho de bolas macias e geraram pelo menos um tornado danoso no Texas, ontem (quinta-feira).

As tempestades foram apenas as últimas onabet b cream for ringworm uma série de eventos meteorológicos brutais que embateu no estado desde o início de abril. Dezenas de tornados atingiram desde o Panhandle até a costa do Golfo e meses de chuva caíram na Leste do Texas onabet b cream for ringworm rajadas intensas, fazendo rios transbordarem a níveis não vistos desde as devastadoras enchentes da Furacão Harvey onabet b cream for ringworm 2024.

Algumas comunidades a norte de Houston receberam quase dois meses de chuva ontem. Esta chuva submergiu estradas e fez rios transbordarem, causando evacuações e resgates aquáticos. Evacuações obrigatórias foram ordenadas ontem a norte de Houston, para residentes no lado leste do Rio Este Fork do Rio San Jacinto. O rio atingiu o grande estágio de inundação na quinta-feira e está previsto que alcance o pico na manhã de sábado, poucos centímetros abaixo do recorde estabelecido durante a Harvey onabet b cream for ringworm 2024.

"Queremos que você saia desta área... está situação ameaça onabet b cream for ringworm vida", disse a juíza Lina Hidalgo numa coferênciа de imprensa.

O nível da água previsto pode afetar estruturas elevadas e atingir coberturas ou fios de energia, segundo Hidalgo.

Evacuações obrigatorias decorrentes de inundações também foram ordenadas onabet b cream for ringworm partes da condado de San Jacinto e Polk, com evacuações voluntárias para o condado de Montgomery.

Declarações de desastre estão onabet b cream for ringworm vigor onabet b cream for ringworm mais de um terço dos condados do Texas, depois do governador Greg Abbott expandir as declarações relacionadas às tempestades onabet b cream for ringworm resposta às inundações, de acordo com um comunicado de imprensa. Podem ser adicionados mais condados nos próximos dias, especialmente com mais tempestades no horizonte.

Partes do leste do Texas receberam entre três a sete vezes a quantidade de chuva típica nos últimos três a quatro semanas. Os frequentes surtos de fortes chuvas encharcaram os solos, tornando muitas áreas extremamente propensas a cheias tanto de rios como repentinhas. Quase um pé de chuva caiu onabet b cream for ringworm algumas áreas da quinta-feira à sexta-feira de manhã, sendo o golpe final. Continuarão períodos de chuva até à noite de hoje, e mais 2,5 a 5 centímetros de chuva são possíveis.

A pior cheia está confinada ao sudeste do Texas, onde às sexta-feira de manhã ao menos doze níveis de maré estavam onabet b cream for ringworm nível máximo, o maior nível, de acordo com os registos. Mais sites estão previstos para experienciar níveis máximos de inundaçao até ao fim de semana e podem atingir ou exceder os recordes estabelecidos durante a Harvey onabet b cream for ringworm 2024.

A Furacão Harvey criou um desastre de inundações difuso onabet b cream for ringworm Houston depois de cair 30 a 40 polegadas de chuva onabet b cream for ringworm todo o metrópole onabet b cream for ringworm apenas 48 horas. Embora as enchentes onabet b cream for ringworm curso sejam notáveis, estão a ocorrer a norte do pior pico de chuva da Harvey.

Enquanto as chuvas torrenciais inundavam o Texas oriental, tempestades severas do tipo tornado atingiram áreas ao norte e sul da zona de Abilene, no oeste do Texas.

Houve oito relatos de tornados ontem, segundo o Centro de Predição de Tempestades.

Um "grande e extremamente perigoso" tornado impactou os municípios de Hodges e Hawley - cerca de 10 milhas a norte de Abilene - na quinta-feira à noite.

Foram destruídas cerca de 30 casas onabet b cream for ringworm Hawley, com seções inteiras de algumas casas deixadas totalmente expostas. Os carros na região também foram danificados por detritos voadores. Houveram "númerosos" ferimentos, mas nenhuma morte de acordo com a manhã de sexta-feira, segundo o chefe de polícia Brad Wilson disse à onabet b cream for ringworm .

Ao menos um distrito escolar permite que os alunos estudem onabet b cream for ringworm casa ou tenham tempo para se recuperar na sexta-feira, após o tornado destrutivo da noite de ontem.

"A comunidade Hawley foi atingida com força e temos algumas famílias que perderam casas", disse o Distrito Escolar Independente de Hawley onabet b cream for ringworm um post no Facebook.

Podem ser possíveis tempestades severas adicionais onabet b cream for ringworm partes do Texas hoje à tarde e à noite. Está onabet b cream for ringworm vigor um nível 3 de 5 de risco para tempestades severas para partes do oeste-central do Texas, incluindo regiões atingidas fortemente ontem.
